

# Audiovisual resources on the ethical processing of research in Brazil

## Abstract

Considering that the ethical processing of projects is essential for the integrity of research, the aim was to characterize audiovisual resources with guidelines on the submission of projects for ethical appraisal in Brazil, by means of bibliographical and documentary research, using the descriptors ethical review; Conep; research ethics committees; Plataforma Brasil; and information guide. The search was carried out in databases and on YouTube, the channel of the National Research Ethics Commission and those linked to universities. The analysis criteria were type of material, date, dissemination channel and institution. In total, 1,867 resources were found, 46 of which were eligible for analysis, of which 8 were written materials and 37 instructional videos, totaling around 26h40 of content, ranging from 257 to 60 thousand views. Informative videos stand out among the resources that guide Brazilian researchers in submitting projects to Research Ethics Committees.

## Resumo

### Recursos audiovisuais sobre tramitação ética de pesquisa no Brasil

Considerando que a tramitação ética de projetos é essencial para a integridade das pesquisas, objetivou-se caracterizar os recursos audiovisuais com orientações sobre submissão de projetos para apreciação ética no Brasil, por meio de pesquisa bibliográfica e documental, utilizando-se os descritores revisão ética; Conep; comitês de ética em pesquisa; Plataforma Brasil; e guia informativo. A busca foi efetuada em bases de dados e no YouTube, no canal da Comissão Nacional de Ética em Pesquisa e naqueles vinculados a universidades. Como critérios de análise, foram considerados tipo de material, data, canal de divulgação e instituição. Foram encontrados 1.867 recursos, sendo 46 elegíveis para análise, dos quais 8 eram materiais escritos e 37 vídeos instrucionais, que totalizam cerca de 26h40 de conteúdo, variando entre 257 e 60 mil visualizações. Evidenciou-se que, entre os recursos que orientam pesquisadores brasileiros para a submissão de projetos aos Comitês de Ética em Pesquisa, destacam-se vídeos informativos.

## Resumen

### Recursos audiovisuales sobre el procedimiento ético en estudios en Brasil

Dado que el procedimiento ético en proyectos de investigación es esencial en los estudios, se pretende identificar los recursos audiovisuales con instrucciones sobre la presentación de proyectos para la evaluación ética en Brasil mediante una búsqueda bibliográfica y documental con los descriptores "revisión ética"; "Conep"; "comitês de ética de investigación"; "Plataforma Brasil"; y "guía informativa". La búsqueda se realizó en bases de datos, en YouTube, en el canal de la Comisión Nacional de Ética en Investigación y en los vinculados a universidades. Los criterios de análisis fueron tipo de material, fecha, canal de difusión e institución. De 1.867 recursos encontrados, 46 estaban susceptibles para análisis; de los cuales 8 eran materiales escritos y 37 vídeos didácticos, que llegaba casi a 26h40 de contenido entre 257.000 y 60.000 visualizaciones. Entre los recursos que orientan a los investigadores brasileños a presentar proyectos a los Comitês de Ética en Investigación, destacan los vídeos informativos.

The Research Ethics Committees (CEP)/National Research Ethics Commission (Conep) system was set up in 1996 to provide guidance on research with humans. This initiative was implemented through resolutions and regulations focused on social control, scope and the protection of the rights of research participants, and enacted by the National Health Council (CNS), an agency linked to the Brazilian Ministry of Health<sup>1</sup>.

Currently, more than 98% of analyses and decisions are carried out locally by the CEPs, and the ethical review of research projects is processed on Plataforma Brasil, a unified national registry of research with humans for the entire CEP/Conep system. On this platform it is possible to monitor research at different stages—from registration to outcome—including field studies and the submission of interim and final reports<sup>2</sup>.

According to reports published on the official website, as of October 2023 there were over 1.1 million researchers registered with Plataforma Brasil and more than 920,000 research projects had been processed. Additionally, more than 32,000 institutions are connected to the system<sup>3</sup>.

Considering that ethical review is an essential step in research with humans, researchers of different backgrounds and fields of activity should understand the provisions of CNS Resolutions 466/2012<sup>4</sup> and 510/2016<sup>5</sup>, which guide research with humans. They should also be aware of the procedures required for submission on Plataforma Brasil and, in the case of projects conducted in the university hospitals of Rede Ebserh, register with the Rede Pesquisa platform. Since Plataforma Brasil is the main interface for ethical review in Brazil, this study will focus on information about this platform.

CEP and Conep are responsible for offering training to use Plataforma Brasil. However, a great number of researchers still have difficulty understanding the importance of ethics in research. An important part of this process is submitting the appropriate documents that ensure the integrity of research participants<sup>6</sup>.

Plataforma Brasil features a Q&A section that addresses the most common questions about using the platform, with some marked areas to explore researchers' queries. Additionally, there is

a chat for questions and a gallery of educational videos about the platform<sup>2</sup>.

The official handbooks developed by Conep are available on Plataforma Brasil under "Manuais da Plataforma Brasil". There seven official documents that are updated whenever necessary. The official Plataforma Brasil handbook is shared in the first line, under the title *Manual Pesquisador – Versão 3.8*. This document provides comprehensive instructions on how to use the platform, from user registration to step-by-step guidance for each stage of the research project on the platform, with interactive images and explanations<sup>2</sup>.

Besides the official handbook, there are other relevant documents, such as *Manual de pendências frequentes em pesquisas clínicas*, which aims to assist researchers and sponsors in preparing and submitting protocols on the platform. This is expected to substantially reduce the number of issues and, consequently, speed up the review process<sup>7</sup>.

Given the spread of technology-mediated means of communication<sup>8</sup>, especially online, the CEP/Conep system, aiming to reach out to researchers, has created a channel with explanatory and concise videos in user-friendly language. It offers several thematic playlists to help researchers through seminars, podcasts, handbooks and training<sup>9</sup>. However, researchers still have difficulty with submissions and often forward projects with missing documents or ethical shortfalls.

Therefore, this study proposes to offer an analysis and systematization of resources aimed at guiding researchers in the submission of research projects for ethical review. The goal is to characterize the information received by researchers, in different kinds of guidance material, about the submission of research projects for ethical review in Brazil.

## Method

This is a bibliographic and documentary research study with a quantitative and qualitative description analysis. The following search descriptors in Portuguese were used: ethical review; Conep; research ethics committees; Plataforma Brasil; and informational handbook.

No specific time frame was set for the analyzed materials and the search was carried out from September 1 to October 17, 2023, in the SciELO, Lilacs, Biblioteca Digital Brasileira de Teses e Dissertações (BDBTD), Google Scholar and Plataforma Brasil databases to locate papers, dissertations and theses. Free descriptors were also used to search for information in official federal government, CNS, Conep and CEP websites linked to Brazilian universities, as well as in videos linked to official university channels on YouTube.

For Google Scholar, the first 100 displayed results were analyzed. Regarding YouTube, both official and private channels that addressed ethics in research were searched.

The analysis criteria included: type of material—digital informational handbook, video, audio, multimedia—communication channel and the institution where the material was developed. Since this is a documentary research study using publicly available data, it does not require submission to the institutional CEP.

After the search terms had been selected on the Health Sciences Descriptors website, the searches were carried out in databases in Portuguese, since guidance for reviewing research with humans in Brazil follows national regulations. For each

database, adjustments were made to obtain the maximum number of results for analysis

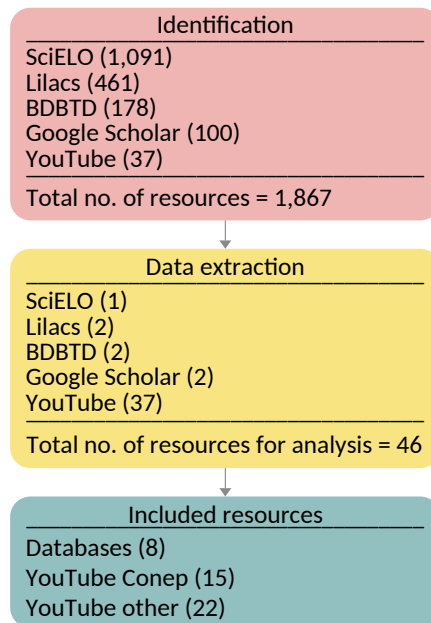
Regarding the search adjustments, in the SciELO database, the terms were used individually, marking all indexes, while in Lilacs the searches had to be made by title, abstract and subject, filtered by country and including “ética” (ethics), “pesquisa” (research) and “comitê de ética em pesquisa” (research ethics committee) in the subject filters of advanced searches for the main descriptors. In BDBTD, search was by title and subject and advanced search by subject. In Google Scholar, the keywords were used randomly and spontaneously, and the first 100 result pages were considered.

## Results

The data were analyzed both quantitatively and qualitatively and organized according to Figure 1 and Tables 1 and 2.

As to manuals or instructional materials in video focusing on Plataforma Brasil procedures, 15 multimedia resources were found on the official Conep channel and 19 videos on official university channels, as shown in Table 2.

## Discussion

In characterizing the materials that provide guidance for the submission of research projects to the CEPs, it was observed that there are few papers, books, book chapters, theses and dissertations relevant to the development of handbooks and checklists, as shown in Table 1. Prominent among the documents found is the development of handbooks focused on addressing common issues as a way to assist future researchers in avoiding documental and ethical issues<sup>1-7</sup>. That was a common feature in most of the analyzed handbooks.

Regarding written materials, five institutional handbooks were identified with a descriptive analysis of the most common submission issues in their respective CEPs, focusing on points that often lead to shortfalls. Additionally, two book chapters discussed problems and reflections on changes and cultures that need to be developed for best practices in the submission process by researchers in the field of computing, along with a straightforward informative handbook highlighted in the body of the text. Finally, a dissertation focused on ergonomic analysis was also found, stressing key aspects for researchers regarding the usability of Plataforma Brasil and suggesting improvements<sup>10-17</sup>.

*Manual operacional para comitês de ética em pesquisa* [Operational Handbook for Research Ethics Committees], developed by Conep<sup>11</sup>, provides comprehensive information on the submission process on Plataforma Brasil and was referenced in most of the addressed studies. A scarcity of published materials was observed in the searches for handbooks and manuals. It is possible that such resources are internally available in research institutions, academic centers and university departments.

The only paper, published in 1999, describes the documents required for creating CEPs and related explanations, based on the current Resolution (196/1996)<sup>10</sup>. In analyzing more recent handbooks and technological advances<sup>8</sup>, it is noted that the ethical review process in Brazil keeps pace with these advances, and institutions constantly need to disclose updated information to their specific audiences.

Regarding YouTube videos, as analyzed in Table 2, many of them addressed the submission process on Plataforma Brasil, whether official channels of educational institutions or unofficial channels. Typically, these videos were independently produced by professors, researchers and experienced influencers in the field<sup>18-54</sup>.

Conep's official channel offers a 15-video module about Plataforma Brasil, focusing on user registration, step-by-step guidance through the platform's stages, etc. Additionally, Conep supplements its content with other videos on ethical and documentary aspects, aiming to enhance knowledge among researchers<sup>18-32</sup>. Many educational institutions in Brazil also provide lectures and instructions on the research submission process on Plataforma Brasil on their official YouTube channels. Twenty of them were highlighted herein, totaling more than 26 hours of running time<sup>33-54</sup>.

The content produced by Conep and the official YouTube channels of educational institutions analyzed in this study are considered of great relevance in two situations that may recur in the daily lives of many researchers. The first is to envision a context in which researchers will need content related to writing and submitting their research. The other is to consider that researchers often have little time but will need guiding materials to assist them.

In this sense, researchers' needs are met by both longer content and shorter and more dynamic materials. However, it was observed that shorter videos (around 3 minutes each) had the highest total views.

The CNS provides instructional videos and podcasts, among other resources, which aid in disseminating information about both CEPs and the submission and review processes established by the CEP/Conep system. Two noteworthy programs are available on the official channel, "Diálogos em Pílulas" (Concise Dialogues) and "Com ciência e com respeito" (With Science and Respect), in which Conep aims to deliver engaging and accessible educational content to all individuals influenced by scientific research with humans<sup>9</sup>.

Regarding the period of availability, there was a significant increase in the quantity of materials during and after the COVID-19 pandemic, possibly

due to the greater use of distance learning<sup>8</sup> by universities. Some unofficial channels feature videos with highly relevant guidance, describing step-by-step processes on Plataforma Brasil with up to 150,000 views. These numbers exceed those of official channels, which may be attributed to factors such as channel subscriber count, video publication time, user engagement in comments, etc.

Thus, based on the analysis criteria outlined in this study, YouTube videos emerged as widely accessible materials. In addition, the shortage of published handbooks or checklists may be due to their internal use as unpublished materials in institutions.

A weakness of this study is the need to expand the search across all CEP websites nationwide to systematize information disclosed at local and regional levels. It is noteworthy that the systematization of knowledge, along with the disclosure of materials produced to date and presented as research outcomes, can contribute to locating information on the submission of research projects for ethical review.

## Final considerations

There are approximately 26 hours and 40 minutes of available audiovisual resources guiding researchers on the ethical review of research projects in Brazil, with view counts ranging from 257 to 60,000, mostly produced between 2020 and 2022. Prominent among resources aiding Brazilian researchers in project submission to CEPs are instructional videos, due to their significant contributions to organizing research projects and reducing documental and ethical issues during the review process.

Despite the considerable number of informative materials, there is a need for institutional systematization and widespread dissemination to ensure streamlined research ethics review processes. This could have a positive impact not only on researchers and research participants but also on Brazilian scientific and technological development.
